ORDER:

Through the reference 2nd & 3rd read above the Special Collector Bheema Project, Mahabubnagar and District Collector, Wanaparthy has approved Preliminary Notification proposals U/s 11(1) and Draft Declaration U/s 19(1) of the Right to Fair Compensation and Transparency in L.A., R&R Act, 2013 seeking acquisition of Open Sites situated with in the limits of Nagarala Village of Srirangapur Mandal Ranga Samudram Balancing Reservoir.


After Award a Adverse News has been published in Andhra Jyothy daily News paper Dt: 23-01-2017 about the acquisition of the Open Sites in Nagarala Village. Thereupon a Three Men Committee has been formed for enquiry. The Three Men Committee has reported that an extent of 17592.40 Sq. Metrs are eligible for passing award towards open sites.

The Special Deputy Collector (LA), RLISP – II, Pebbair vide Lr. No. B/142/2015, Dt: 24-07-2018 stated that during his enquiry it has been revealed that the beneficiaries of the Open House Sites have not submitted any documentary evidence or owner ship certificate and hence he presumed that the open area comes under "Abadi" and he is not able to pass any award, and requested to clarify the matter in this regard. The same has been addressed to the Government for clarification vide G/C1/321/2016, Dt: 17-07-2017.

Hence as per Section 25 of the Act 30 of 2013 and G.O. Ms. No. 6, Dt: 17-01-2017 the District Collector who is the appropriate Government is hereby extends for a period (40) days of passing award, due to certain doubts expressed from the Special Deputy Collector (LA), RLISP – II, Pebbair and further clarification required from the Government of Telangana.
